They also explore what is meant by respect for human remains, and how we should demonstrate this, and they examine how some remains are treated differently than others (the recent dead vs. the ancient dead, as well as the different 'categories' of people), why this is, and where the boundaries are. The different uses of remains (for exhibition, teaching, or scientific research) are also covered. This topical collection of essays will be essential reading for anyone involved in the discovery, moving, display, or study of human remains.
